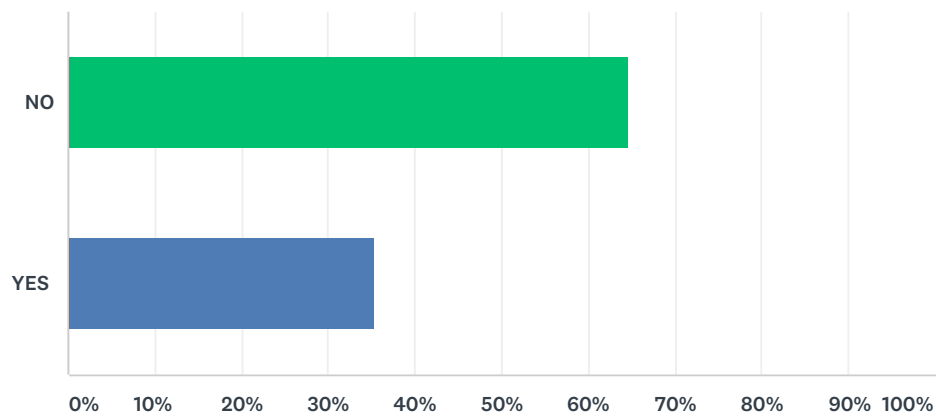


Q1 Should the Town prohibit the sale, commercial cultivation, manufacturing and testing of marijuana and marijuana products in Damariscotta?

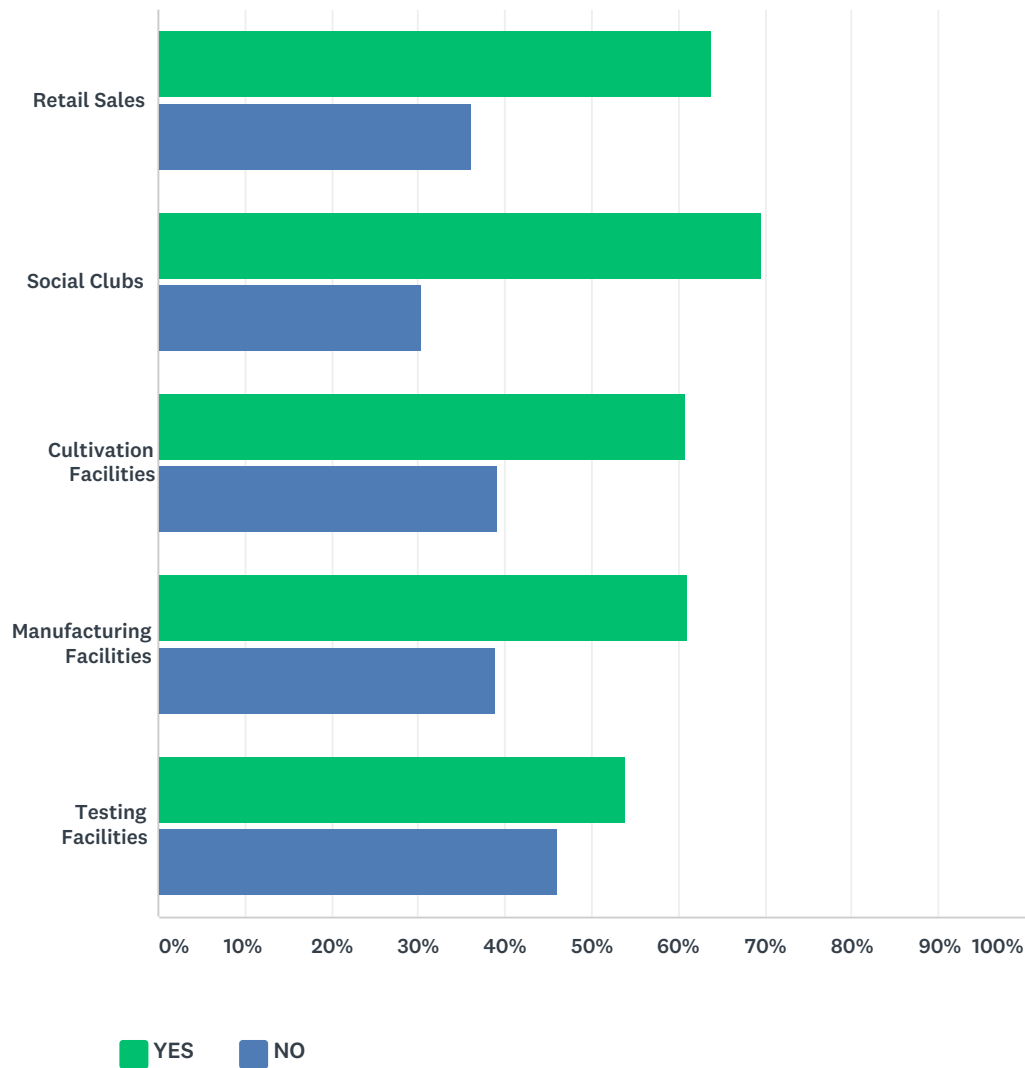

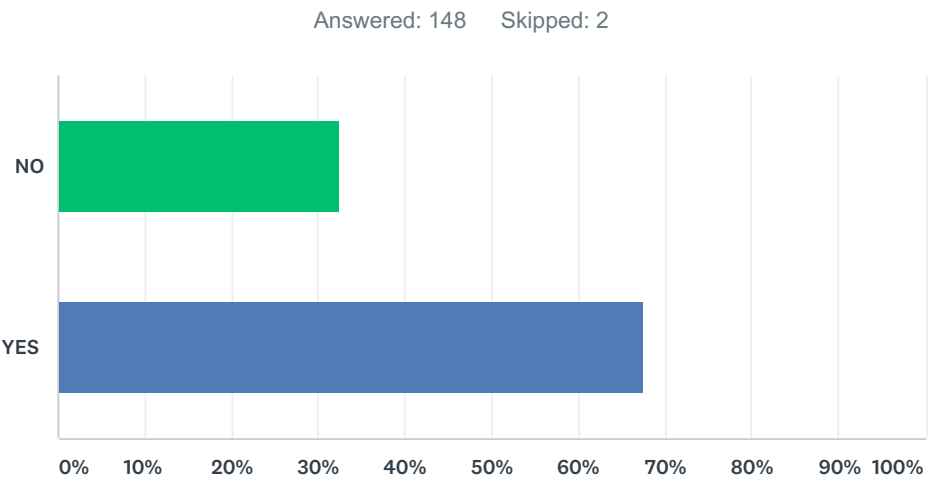
Q2 Assuming commercial marijuana activities are allowed in Damariscotta , should there be a limit on the number of licenses issued in Damariscotta for any of the categories?

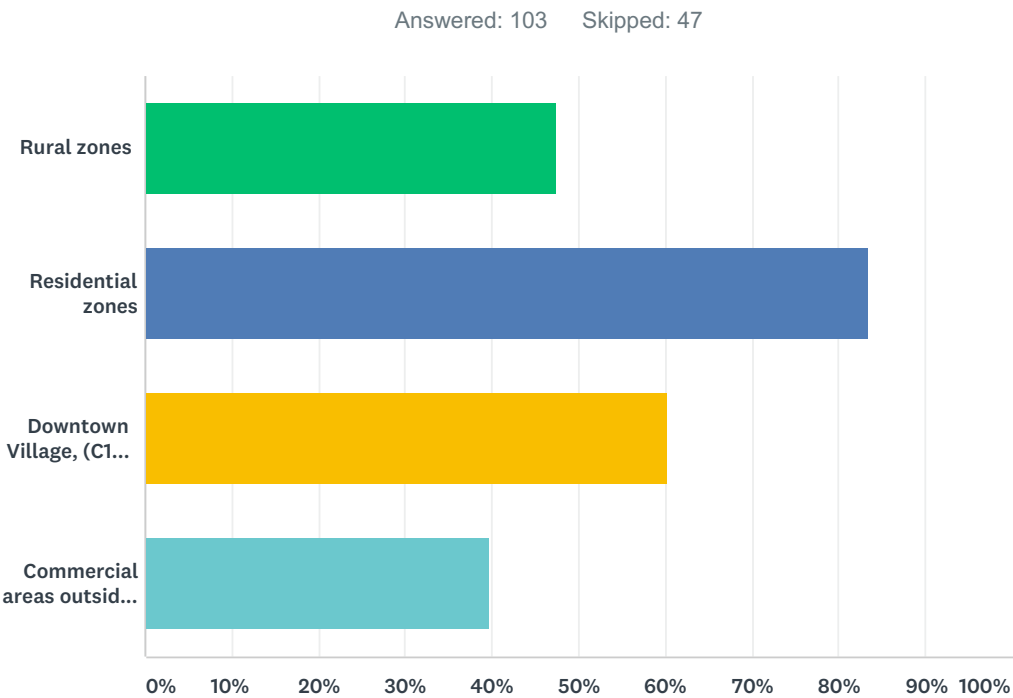

Q3 Should marijuana retail sales be limited to specific areas of Town?



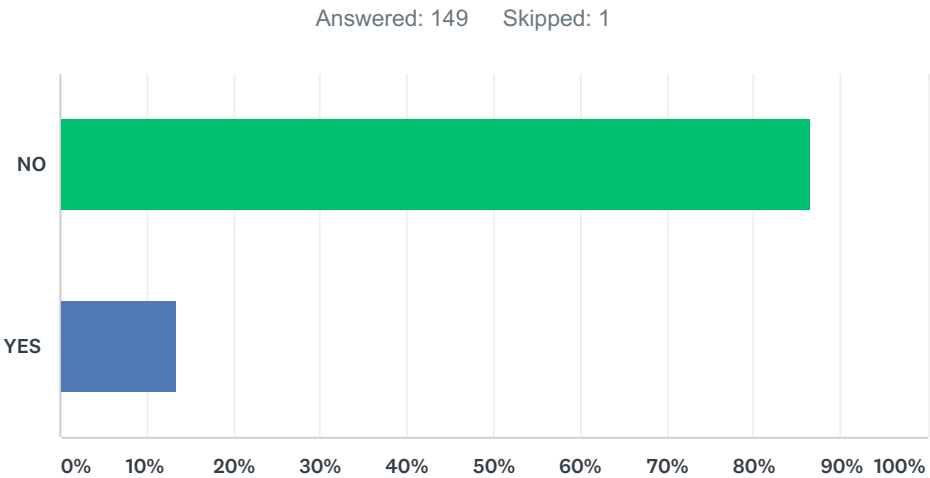

Q4 If you answered yes to Question #3, Where should retail sales NOT be allowed? (Check any that apply)



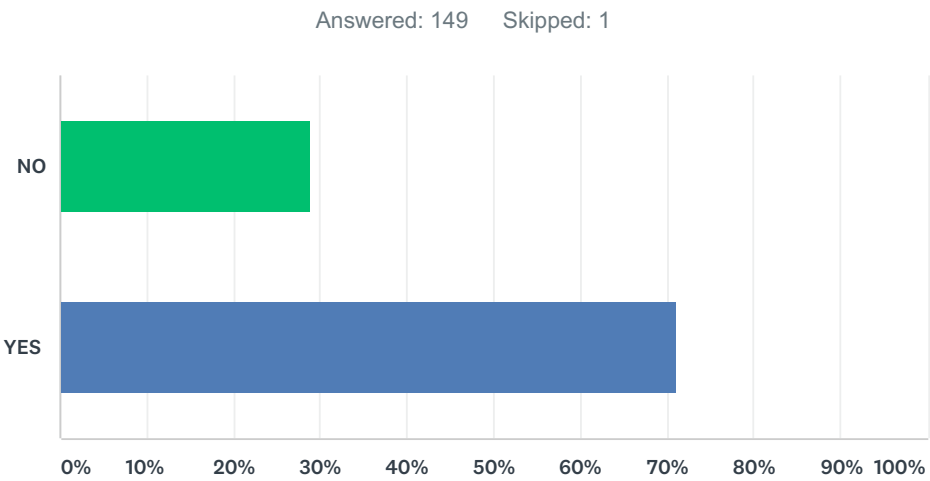

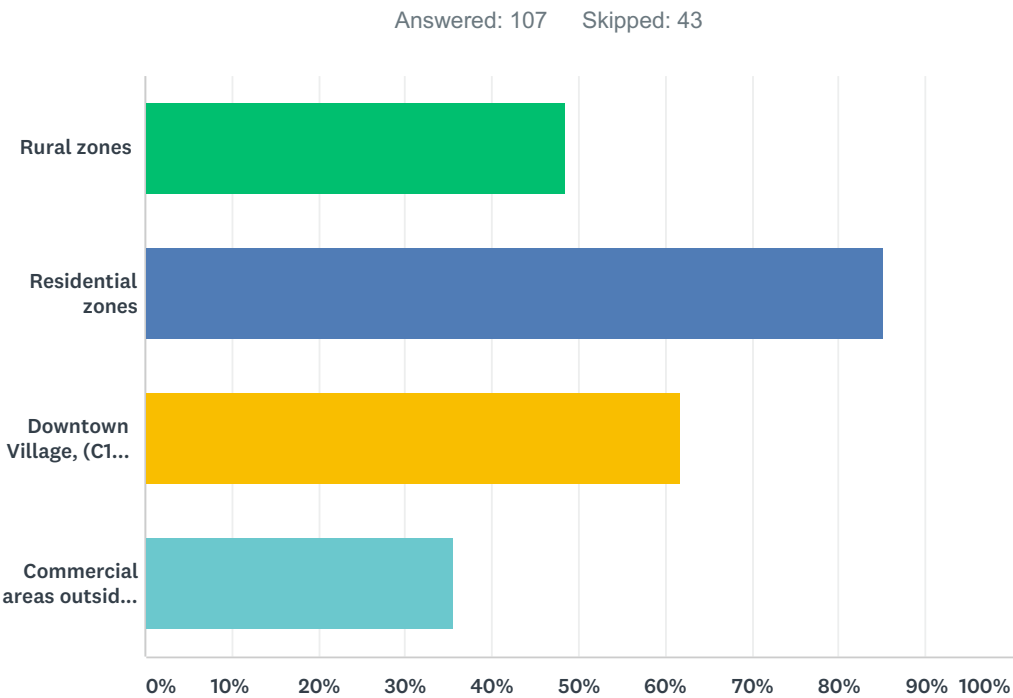

Q6 Should marijuana social clubs be limited to specific areas of Town?



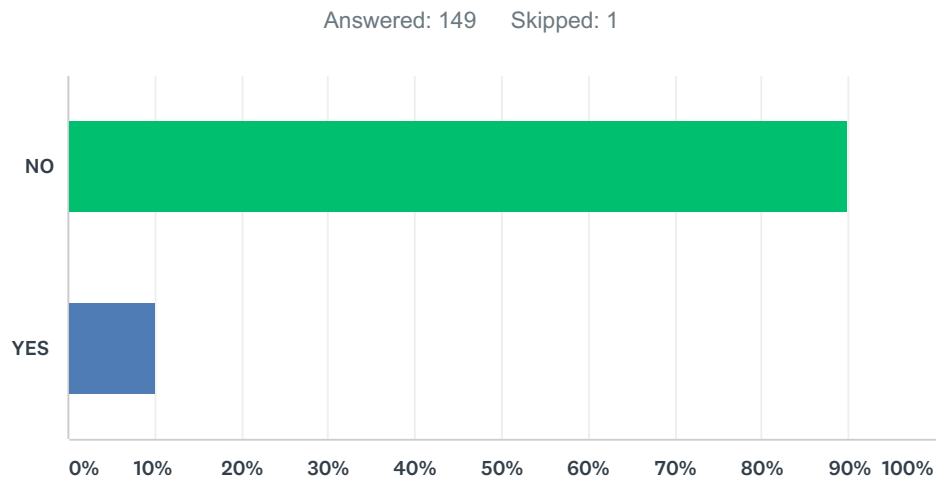

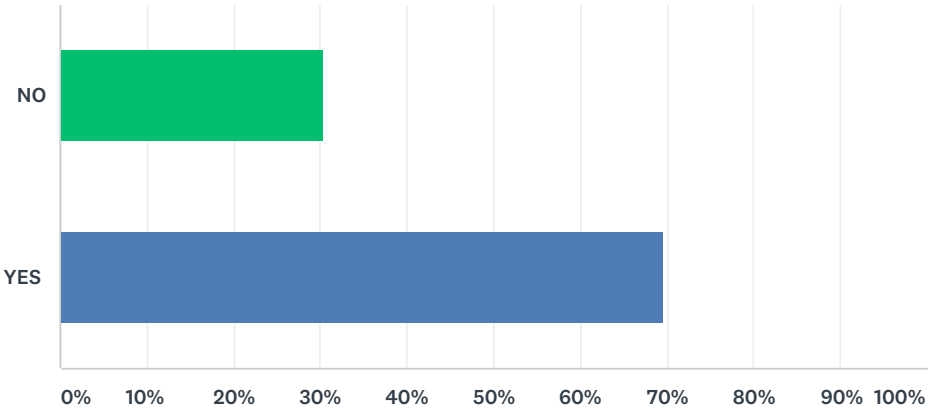
Q8 Should social clubs be allowed within 500 feet of schools and daycare centers?

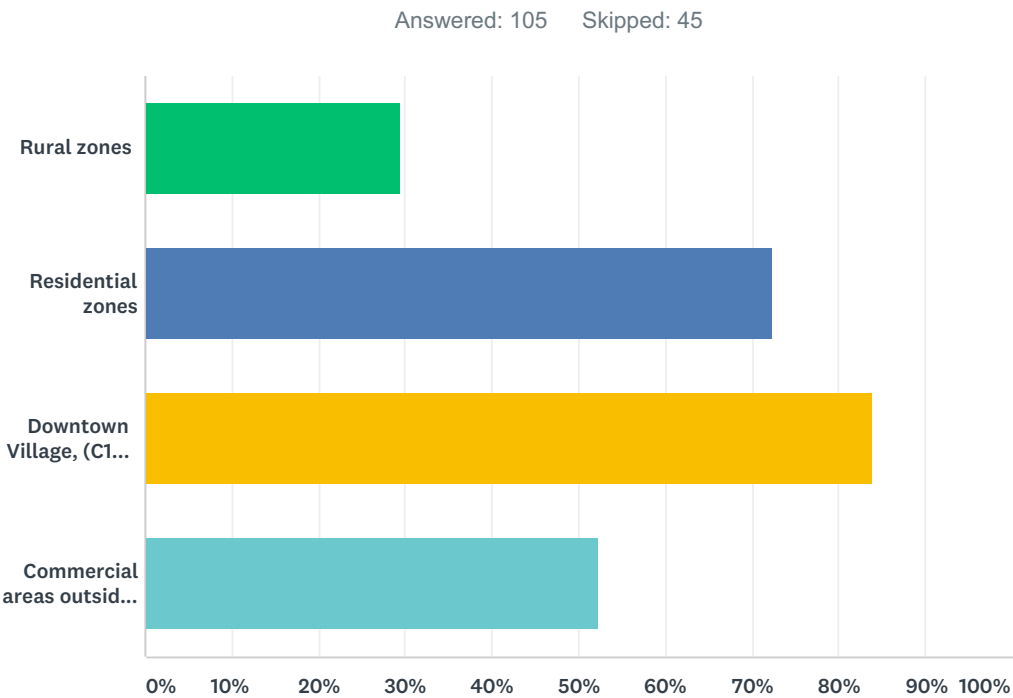
Q9 Should commercial marijuana cultivation facilities be limited to specific areas of Town?

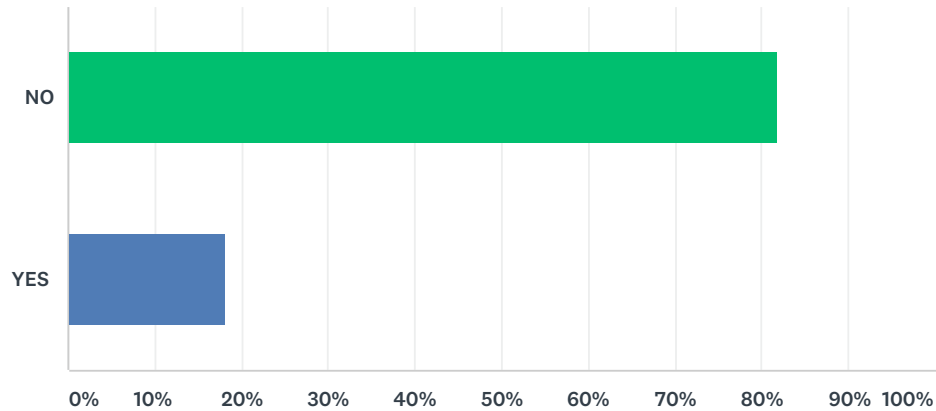
Q10 If you answered yes to Question #9, where should commercial cultivation facilities NOT be allowed? (Check all that apply)

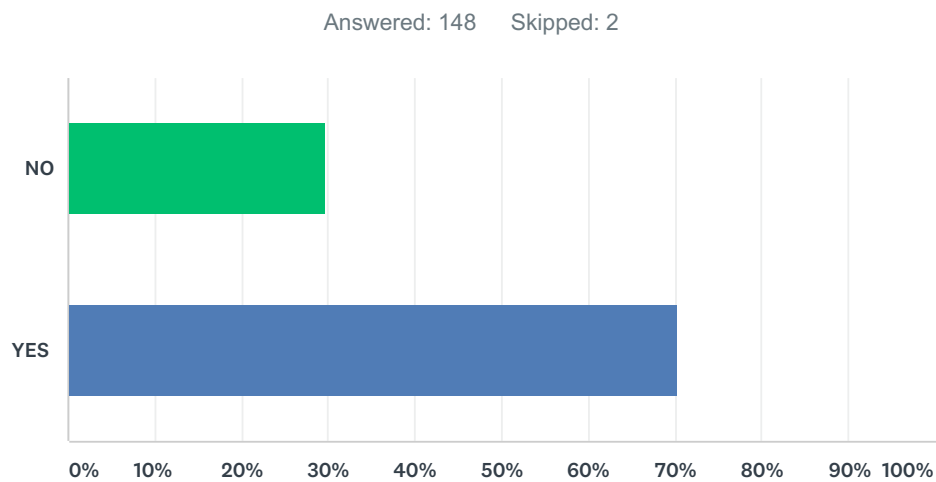
Q11 Should commercial cultivation facilities be allowed within 500 feet of schools and daycare centers?

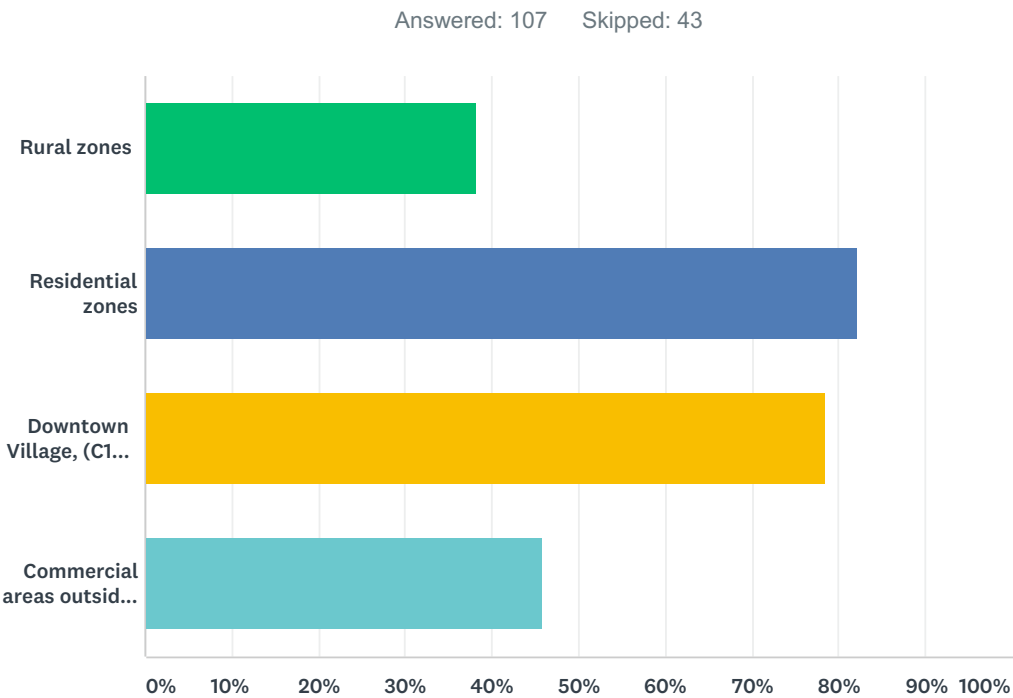

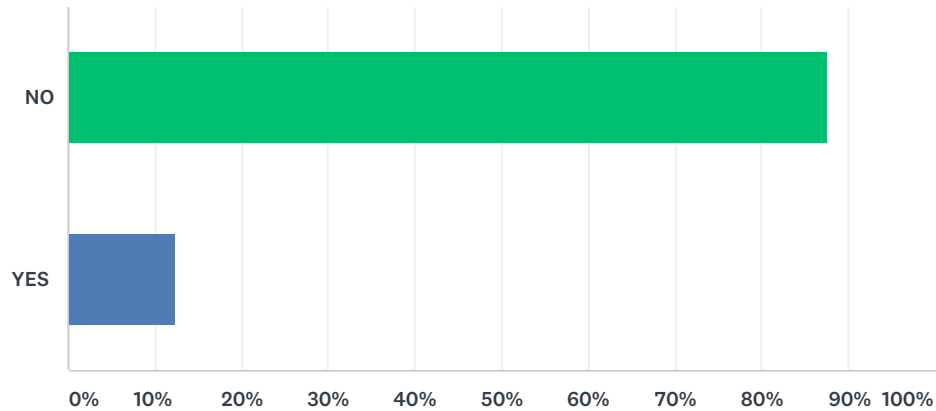

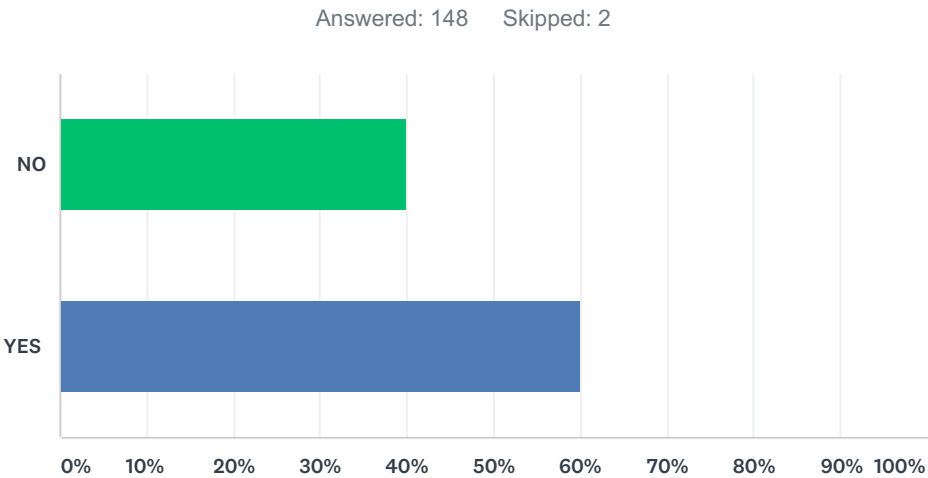
Q14 Should manufacturing facilities be allowed within 500 feet of schools and daycare centers?

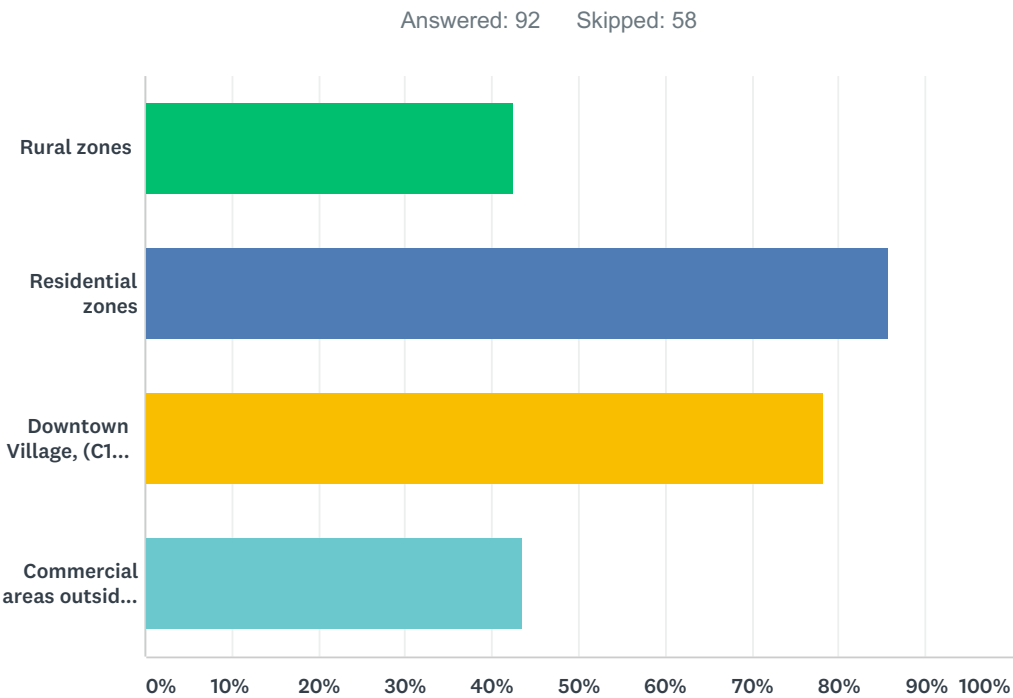

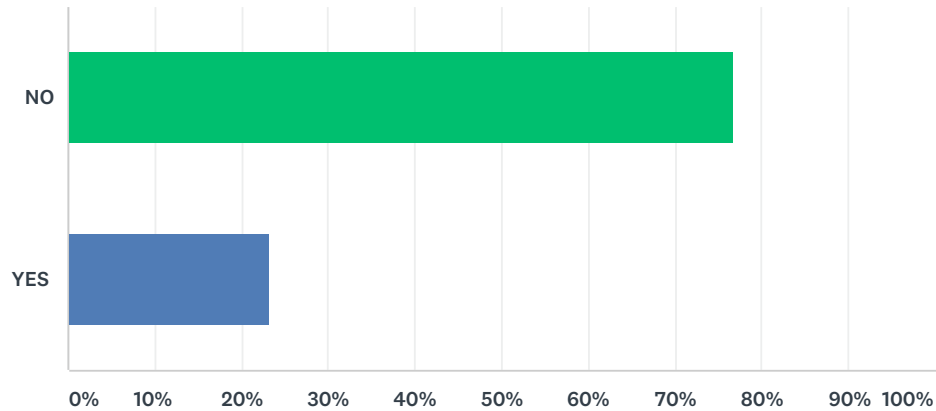

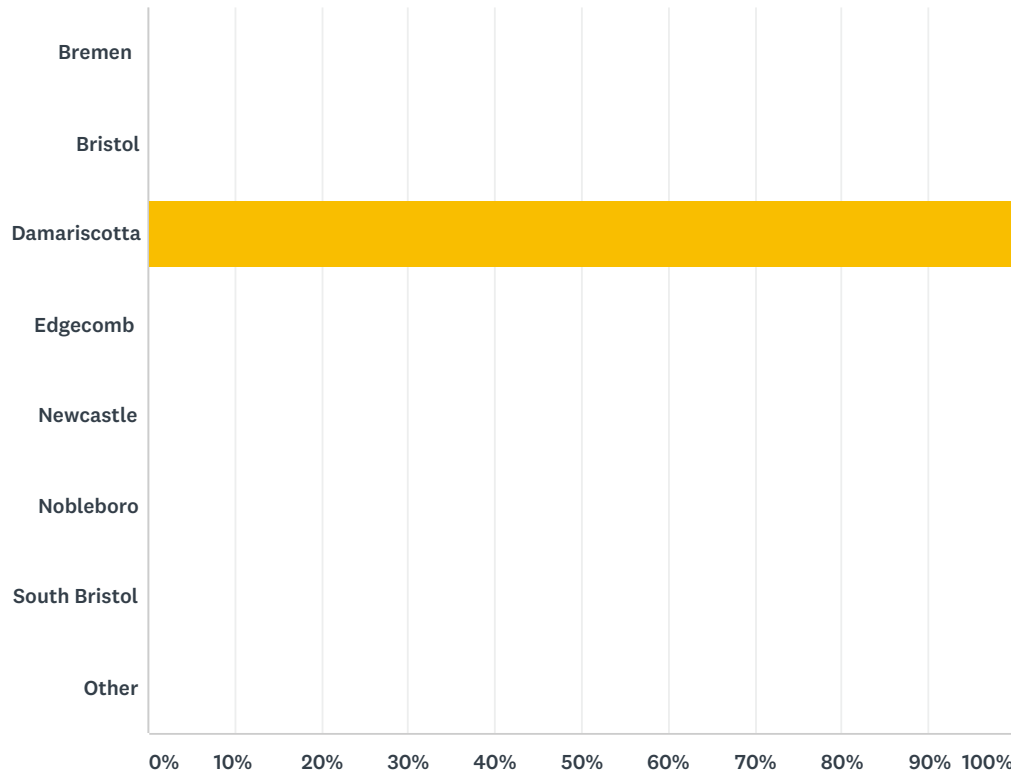
