Explanation: The additional local funds are those locally raised funds over and above the District's local contribution to the total cost of funding public education from kindergarten to grade 8 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state-funded debt service that will help achieve the District's budget for educational programs.

ARTICLE 14 (Recorded vote): To see what sum the District will authorize the CSD Board to expend for the fiscal year beginning July 1, 2023, and ending June 30, 2024, from the District's contribution to the total cost of funding public education from kindergarten to grade 8 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, \$15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.

The amount must be the gross budget of the school system. This article does not provide money unless the other articles are approved.
