Dear Selectmen:

Thank you so much, for your support of Healthy Kids. On behalf of Healthy Kids, I am writing to request support in the amount of \$2,200. Healthy Kids has been the Child Abuse Prevention Council of Lincoln County since 1985. Healthy Kids has a working board of directors and employs two full time and one part time staff for Lincoln County services and programs. As of July 2023, Healthy Kids expanded its prevention services to include Knox County, employing one other full time educator and one part time staff dedicated to the Knox communities. Our mission is to encourage, support and promote the healthy development of our children so that they may grow into healthy, contributing members of our community.

We want you to know that Healthy Kids has provided services directly to 721 Damariscotta residents. Many more Damariscotta residents continue to utilize the 6,017 service units of our social media activities (Facebook, Facebook Live and Instagram) for families with younger children, our website parenting resources and our LCTV series on parenting, but we were unable to specifically count them by town. Additionally, 17 parents from Damariscotta actively engaged in our resource center and/or referral system. Participants of our programs include parents, teachers, students, children, day care providers, physicians, law enforcement, school board members, town council members and general assistance staff, service club members, inmates, and other community representatives including residents who may work with children elsewhere in the county and still receive professional training. The direct services provided in Lincoln County last year were:

- Monthly parenting tips produced by Healthy Kids and distributed through the schools and day cares for families with children ages 0-14
- Personalized parenting support/coaching
- Community Dinner events at elementary schools with food, games, parenting tips and take-home family activities
- Supervised Visitation ordered by DHHS and/or the courts
- Parenting groups, workshops, and classes in-person or by Zoom as requested
- An on-site weekly playgroup, which started back in-person beginning February 2023
- School and Day Care based child abuse prevention programs
- Family Resource Center, lending library, Christmas toys handed out in a drive through and free informational resources
- Parenting programs at Two Bridges Regional Jail
- Mandated Reporting, Safe Sleep, Period of Purple Crying and Strengthening Families programs for professionals who work with children as well as HS students
- Periodic Facebook Live activities for families with young children
- LCTV TV series on parenting topics
- Educational classes were offered to four Lincoln County high school health classes teaching students about Shaken Baby Syndrome (preventing head trauma), the impact of drugs and alcohol on babies and basic infant care

We will continue to provide services to the professionals and families in Damariscotta and again, thank you for your support!

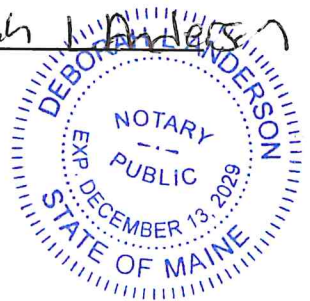
