## **GREETINGS:**

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Damariscotta, in said County, qualified by law to vote in Town Affairs, to assemble at the Damariscotta Municipal Building, 21 School Street in said Town, on Wednesday, the 15<sup>th</sup> of February. 2023 at 5:30 PM, then and there to act on Articles 1 through 5.

**ARTICLE 1.** To choose a Moderator to preside at said meeting.

**ARTICLE 2.** Shall the Town vote to enact the amended Land Use Ordinance as presented to the Select Board on February 1, 2023?

more precisely described in the Transfer Agreement; and (2) grant to the District an easement that allows for use of the Municipal Parking Lot in the area of the sewer lines to construct, install maintain, repair, alter and replace the lines, with the rights of both parties being more fully described in the Sewer Easement Deed; and (3) authorize the Select Board to take any and all actions necessary to finalize the documents needed to complete this transfer of ownership and conveyance of an easement?
