Board reviewed Draft 2b sign ordinance line by line.

- 1. Purpose
- -Line 4-Replace "beauty of the Town" with "character of the Town"
- -Also need to regulate color, texture, and lighting
- 2. Definitions

Changeable signs

- -Eaton Ordinance can limit: number, size, lighting, color, text only. Clarify difference between scrolling and flashing signs.
- -Hagar likes option for changeable signs for Great Salt Bay School, could change from office for emergency.
- -Dater Need to decide if want flashing signs along Route 1B. Can require all lighted signs to be shielded and not flashing; require permit to allow CEO review. For grandfathered signs, can set a time limit to bring into compliance.

Eaton – many existing backlit; a small lit open sign is sufficient for gas station; need to address inflatable signs.

Dater – If add definition for inflatable signs, can prohibit sign and all moving parts. Sage – Limit light pollution

Dater – Downtown signs are addressed in Shoreland Zoning Ordinance.
