## TOWN MANAGER NOTES FOR MARCH 6, 2019 BOARD OF SELECTMEN'S MEETING

#### **Financial Reports**

Annual Financial Audit- Fred Brewer will review the Fiscal Year 2018 Audit with the Board.

**Town Manager Items** – I will likely have several verbal updates for you.

#### **Official Action Items**

1. **Keypad Voting System Purchase-** Following up on the Board's request at your February 20 meeting, Michelle Cameron has obtained pricing from Dynamic Services International on the purchase of a keypad voting system. She has also been in contact with the Town of Newcastle to see if they would be willing to have our two towns share keypads when either of us expect larger than normal attendance at our respective meetings. We have yet to hear back from them on a decision.

Three purchase options from Dynamic Services are attached. I believe that the option with 150 keypads would be the best choice at this point. Town staff will continue to see if one or more other towns would be willing to share equipment.

Town staff are recommending that the Town purchase a projection screen and a new projector at the same time we purchase keypad system. We do not currently have a screen and the projector that we have is technologically outdated. The cost for the screen and projector is \$670.97.

Since funds were not budgeted for the keypad system, the expense will need to be charged to the Town's contingency account. Funds are currently available in this account to cover this expense.

Recommended Actions: Approve the purchase of a keypad voting system from Dynamic Services International for \$3,750 and the purchase of a projector and projection screen from B&H Photo for \$670.97.

Approve the use of FY 2019 Budget contingency funds in the amount of \$4,420.94 for these purchases

2. Fund Balance Transfer for Traffic Signal Expense- As the Board is aware both of the traffic lights in town are set to operate on a green-yellow-red cycle except during the late evening and early morning hours when the lights automatically switch to flashing yellow and red. In December, the lights failed to switch back to the green-yellow-red cycle. The contractor that the Town uses for signal maintenance determined that the controller did not operate properly due to damage caused by mice. The cost to replace the controller was \$14,626.99. The traffic signal maintenance budget does not have sufficient funds to cover this expenditure. I am therefore asking the Board to approve the use of money in the Town's contingency budget account.

Recommended Action: Approve the \$14,626.69 expense for emergency repairs to the traffic signal at Main Street and Bristol Road and charge this expense to the contingency account in the FY 2019 Budget.

- 3. **Contract for Town Paving Projects-** The closing date for bids for the Towns' paving projects is next Tuesday, March 5. The Public Works Committee will be reviewing the bids and will have a recommendation for the Board prior to Wednesday evening's meeting.
- 4. **Resignation from Budget Committee** This past week, Joyce Polyniak sent the Budget Committee Chair an email indicating that she could no longer serve on the Committee. Since the Committee's work on the FY 2020 Budget has already begun, my recommendation is to not fill the position but rather to wait for a new member to be elected at the June Town Meeting.

Recommended Action: Accept Joyce Polyniak's resignation from the Budget Committee.
