Town Manager Notes for December 16, 2020 Board of Selectmen's Meeting

Presentations

1. **Update on Broad Reach Shellfish Resource Sustainability Study** –As the Board will recall, the University of Maine Daring Marine Center staff are working on a shellfish resource sustainability study for the Newcastle/Damariscotta Shellfish Committee and the Towns of Bremen and Damariscotta. Despite the COVID-related restrictions placed on the project team, Darling Marine Center graduate students Melissa Britsch and Sarah Risley are continuing to forge ahead with their survey of shellfish harvesters and others who have knowledge of shellfish populations and use patterns in the rivers.

Melissa and Sarah will provide an update of the project and will be able to respond to any questions that the Board and others on the Zoom call might have. Dr. Heather Leslie, Director of the Darling Marin Center will also participate in the call. Members of the Shellfish Conservation and Harbor Management Committees and Newcastle, Bremen and Bristol Town officials have been invited to join the meeting.


Questions Guiding 2019 Shellfish Study

- What is the current state of shellfish populations (softshell clams, quahogs, and oysters) in the Damariscotta River estuary?
- 2. Are young shellfish (i.e. seed) recruiting to the estuary?
- 3. How have shellfish populations in the estuary changed over time?



2019 Study Findings


- Shellfish populations varied among locations and by tidal height.
- Recruitment of young softshell clams varied with tidal height. Showed effects of predators on young clam survival rate.
- Harvesters noted that shellfish populations in the estuary have changed over the last 20 years.

2020: Pivoting in Response to the Pandemic

- Initially planned to continue shellfish surveys
- But, field surveys not possible due to COVID-19 restrictions in the spring
- Developed another approach to collect information on shellfish populations, from a safe distance



2020 Project Goal and Expected Outcomes


To document local knowledge of the Damariscotta River estuary in and effort to...

- Collect information on:
 - Softshell clam abundance and wild shellfish diversity
 - How shellfish abundance and diversity has changed through time
- Identify:
 - Areas of importance for wild shellfisheries to inform future field work in 2021
 - Areas of shared importance for different river uses



Local Knowledge Mapping Study

- Study distributed by mail
- Two part study:
 - Mapping Booklet
 - Phone Interview
- Gathering information on:
 - Location and abundance of shellfish and use
 - How the shellfish populations and use in the estuary have changed





Clam Abundance





CEMETERY DEED

KNOW ALL PERSONS BY THESE PRESENT that the Town of Damariscotta, in the County of Lincoln in the State of Maine, a municipal corporation organized and existing under the laws of the said State, in consideration of the sum of *six hundred* dollars (\$600.00) paid by *Ronald W. and Carolyn E. West* in the State of Maine, does hereby transfer and convey unto the said *Ronald W. and Carolyn E. West* and his/her assigns, a certain lot of land in *Hillside* Cemetery – *Annex 2* in said Town of Damariscotta, said lot(s) being numbered 1072 & 1073 as shown on the plan of the cemetery on file with the Trustees of said cemetery.

TO HAVE AND TO HOLD the same unto the grantee(s) and assigns forever.

ON CONDITION that:

- 1) the same shall be used and improved only as and for a burial lot for the human dead;
- 2) no permanent markers shall be erected above the surface of the ground, other than permitted monuments;
- 3) no shrubbery or trees shall be planted on the lot;
- 4) the lot shall not be mounded or terraced (grade to be maintained on level with the rest of the area);
- 5) it can only be sold to the Town of Damariscotta;
- 6) it can be transferred only with prior written permission from the Trustees of said cemetery; and
- 7) the owners and possessors thereof shall always be subject to such regulations and orders as are or shall be made for the use and improvement of said cemetery.

The said Town of Damariscotta covenants to and with *Ronald W. and Carolyn E. West* and his/her assigns that it is lawfully seized in fee of the aforesaid premises, that the granted premises are free from all encumbrances, that it has good right to sell and convey the same to the said *Ronald W. and Carolyn E. West* and his/her assigns forever.

IN TESTIMONY WEHREOF, the Town of Damariscotta has caused these present to be signed and sealed by its Selectmen, thereunto duly authorized this 2nd day of December, 2020.

West, and said sum has been accepted by said Town, to be held in trust, the income thereof to be used for the perpetual care and maintenance of lot number(s) 1072 & 1073 in *Hillside* Cemetery-Annex 2; provided, however, that should any part of said income remain unexpended after the reasonable and proper care of said lot, said income shall be used for the general care and maintenance of *Hillside* Cemetery.
